Trustees' Annual Report Year ended 31 December 2022

Structure, Governance and Management

Governing Document

The Church is administered in accordance with the terms of the Deed of Constitution.

Recruitment and Appointment of Trustees

Members of the Kirk Session and the Congregational Board are the charity trustees. The Kirk Session members are the elders of the church and are chosen from those members of the church who are considered to have the appropriate gifts and skills. The minister, who when appointed, is a member of the Kirk Session, will be elected by the congregation and inducted by Presbytery. The Congregational Board is appointed from within the congregation and members of the congregation are invited to nominate individuals, who are believed to have the skills and commitment to contribute to the management affairs of the Church, to become members of the Board. Board Members are then appointed at the Stated Annual Meeting and serve for a period of three years after which they must seek re-election at the next Stated Annual Meeting.

Organisational Structure

The Congregational Board is chaired by an elected board member and meets at least four times in a year. Certain responsibilities are delegated to the Finance Committee and the Property Committee as appropriate. The Kirk Session which also meets at least four times a year is responsible for spiritual affairs within the church. The Church is linked with Avonbridge Parish Church of Scotland and shares some expenses and staff with them.

Objectives and Activities

The Church of Scotland is Trinitarian in doctrine, Reformed in tradition and Presbyterian in polity. It exists to glorify God and to work for the advancement of Christ's Kingdom throughout the world. As a national Church, it acknowledges a distinctive call and duty to bring the ordinances of religion to the people in every parish of Scotland through a territorial ministry. It co-operates with other Churches in various ecumenical bodies in Scotland and beyond.

Worship is normally conducted in the church each Sunday at 11.15 am and using Zoom at 7.00pm. Services in the Kirk were recommenced on Advent Sunday (28 November 2021), but only three services were held before being suspended again due to the impact of the COVID-19 Omicron variant. Services in the Kirk resumed at the start of Lent 2022, 5 March 2022.

We have strong links with World Mission and through our Mission Partners who work in Africa with AIM we have formed a partnership link with Magina Presbyterian Church of East Africa, Limuru Presbytery in Kenya. In 2006 the Minister made an inaugural visit to Kenya to visit our Mission Partners and in 2008 we hosted a reciprocal visit from members of our partner church in Kenya. Subsequently, in 2011, two members from Torphichen and Avonbridge visited Magina.

The Eco Congregation Project is an integrated syllabus for all churches, which we use to help make our mission, buildings, witness, and lifestyles more sustainable and environmentally responsible. We were the fourth congregation in Scotland and the first in the Lothians to receive this award and have gained our second award. We have an active Eco-Committee, and we host the area meetings of the

Eco Congregation Network, which are held quarterly and in so doing seek to encourage other congregations and communities to share in this valuable work.

The following activities, which are part of our normal congregational life, have been suspended because of COVID-19. Most of these were not resumed in 2022.

Our Sunday School, known as the Adventurers, participate in the first part of each Sunday service before moving into their groups.

New Members' courses are run on demand, and study groups meet during Lent and at various other times of the year.

Special services include a Watchnight service at 11.30 pm on Christmas Eve and Easter Sunday open air service on Cairnpapple Hill at 8 am. Pulpit exchanges with Presbytery and Bathgate Churches Together are annual events.

Monthly Coffee Mornings are staffed and run by an enthusiastic band of volunteers binding the community together. Other church and village groups are offered an opportunity to host individual coffee mornings to enable them to raise funds. We also host a permanent second-hand book stall in our hall to recycle books.

Torphichen Summer Nights Music Society organises concerts in our church during the summer months and gathers many people from the region to enjoy a high standard of music. These events combine the talents and enthusiasm of a range of people from across our community and enhances the links with church and community.

Mums and Toddlers, Twins Group and other community events meet regularly in our hall.

Members visit Blackfaulds Nursing Home monthly to hold a worship service.

Achievements and Performance

Pastoral Care for the Community is provided by the Locum Minister, Kirk Session and members of the congregation and is also carried out through the regular offices of the church through Baptisms, Weddings, and Funerals. During the COVID-19 pandemic, our locum minister regularly phoned all members. The pastoral care team phones and sends flowers and cards to those whom they are aware are ill, bereaved, etc.

The now monthly Church Magazine (CHAT) goes to all members of the congregation and is online or delivered by email or by post. A Kirk page is included in the monthly Community Council's 'Torphichen News.'

The Kirk's Facebook page and website are continually updated with services and details of local and national church events.

Financial Review

The four principal sources of income that we receive are through open-plate offerings, freewill offerings, fundraising, and tax recovered on gift aid.

This year's accounts have been prepared as income and expenditure, and shared expenditure shown as gross amounts, with an analysis of the contribution from our linked congregation on page 11.

In 2022, we were able to meet our Ministries and Mission contribution from regular donations.

Gift Aid claims for 2020 onwards are being processed, and payment is expected in 2023.

Reserves Policy

It is the Trustees' policy to hold reserves of approximately six months expenditure. At the year end the Church held unrestricted cash funds of £77,104 of which £702 has been designated for a Disabled Access fund, £1,493 for Fabric, £19,088 for the Manse fund, £998 for the Youth Club fund, £471 for Torphichen and Avonbridge Church Orchestra, and £8,594 for a legacy fund. The sum of £45,758 within the General Fund is more than 6 months of last year's expenses.

Restricted funds are held totalling £22,972, with £22,972 for the Fabric Redevelopment fund, and £0 for Magina (our linked congregation in Kenya): it is hoped that during 2023, fundraising might recommence for this.

As at 31 December 2022, the Church held funds of £100,076 in total.

Statement of Trustees' Responsibilities

The members of the Kirk Session and Congregational Board must prepare financial statements which give sufficient detail to enable an appreciation of the transactions of the Church during the financial year. The members of the Kirk Session and Congregational Board are responsible for keeping proper accounting records which, on request, must reflect the financial position of the Church at that time. This must be done to ensure that the financial statements comply with the Charities and Trustee Investment (Scotland) Act 2005, the Charities Accounts (Scotland) Regulations 2006 and the Regulations Anent Congregational Finance approved by the General Assembly of the Church of Scotland in 2007. They are also responsible for safeguarding the assets of the Church and must take reasonable steps for the prevention and/or detection of fraud and other irregularities.

Independent Examiner's Report to the Trustees of Torphichen Parish Church of Scotland

I report on the accounts of the charity for the year ended 31 December 2022 which are set out on pages 7 to 12.

Respective responsibilities of trustees and examiner

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006.

The charity trustees consider that the audit requirement of Regulation 10(1) (d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1) (c) of the Act and to state whether particular matters have come to my attention.

Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.

Independent examiner's statement



The Trustees have set aside funds as follows:

Unrestricted

Disabled Access Fund: the maintenance of disabled access at the Church and Hall.

Manse Fund: has been established so that income raised from rental of the Manse can be reinvested in the property.

Fabric Fund: major fabric expenses.

Youth Club Fund: fund for use by the Youth Club.

TACO Funds: use by Torphichen and Avonbridge Church Orchestra. This fund includes a factor of linkage with Avonbridge Parish Church.

Legacy Fund: from a legacy, for use as decided by the Trustees.

Restricted

Magina Fund: for our linked congregation in Kenya. In 2021, all funds were dispersed to Magina. The fund will be built up again when usual fund-raising activities resume.

Fabric Redevelopment Fund: for major anticipated expenditure on the Kirk and St John's Hall.
